
Sub: Online and Offline Examinations (Simultaneous) of the 6th Semester Examinations of the BA, B.Sc. and B.Com Programmes, 2020

On recommendation by the Committee constituted vide Memo No. DU/RG/G.01.01/2020/4014 dated 16.09.2020, the Hon'ble Vice-Chancellor, Dibrugarh University is pleased to approve facilitation of **Online Option** to the candidates of the 6th Semester Examinations of the BA, B.Sc. and B.Com Programmes, 2020 along with the Offline system.

In context of the above, following decisions are taken for all concerned-

- (i) The University will facilitate/extend the **Online mode** of Examinations for intending candidates of the 6th Semester Examinations of the BA, B.Sc. and B.Com Programmes, 2020 along with the **Offline mode** as already notified by the University.
- (ii) **The Online and Offline Examinations will be held simultaneously.** The Examinations shall be conducted as per the Time Table already notified on 16.09.2020 by the Controller of Examinations i/c, Dibrugarh University.
- (iii) **Standard Operating Procedures (SoPs)** will be notified separately for **Offline** and **Online** modes of Examinations very soon. Compliance of the conditions laid down in the SoP (s) will be mandatory for all.
- (iv) The candidates intending to appear examinations in Online mode **must register** themselves in the dedicated web portal, which will be notified in the website www.dibru.ac.in. The University shall notify the **Relevant Information Regarding Registration** by intending candidates to appear the examinations in **Online mode**. The Registration process for appearing the Examinations in Online Mode shall be given in the SoP to be notified shortly.
- (v) **Only the Candidates who will get the Password through the prescribed Registration Process shall be eligible to appear the Examinations in Online mode.**
